TREASURER REPORT TO May 10th MEETING ACA

The Trans Tasman Event has been successfully completed and the cost of hosting are approx. \$1600 under budget. This is mainly due to Tournament Manager & Tournament Referee being local. There is a request to consider a payment to WA Referee for travel costs. Team costs were also well under budget. We need to put clear guidelines in place as to what is able to be funded for these teams. This will assist the Team Manager to understand the limits.

Travel assistance for the GC Pres 8's has been distributed in accordance with policy. There was a payment of 70.66% of their adjusted costs due to the number able to claim and distances involved. I would recommend a review of the formula as people travelling by vehicle seemed to be more favourably reimbursed than those flying from further afield.

The majority of Magazine subscriptions have been refunded. We are still waiting for bank details for the balance. Six subscribers have chosen to donate the refund to ACA (\$210.00).

\$35000 has been reinvested in term deposit for 9 months at 2.45%

Invoices for 2018 affiliation fees will be sent out this month to the States.
