MOTION:	That Australian Croquet Association assume the administration of the Ricochet discipline from 2018.
LODGED BY:	Croquet Queensland
BACKGROUND TO MOTION:	See attached (Appendix 4) (a) Part I History of Ricochet in Queensland and (b) Part II History of Ricochet in Queensland.
	The documents indicate that, since Queensland assumed the administration of Ricochet, the discipline has grown quickly, with Director of Ricochet James Finemore reporting that there were now Clubs from most Queensland States and New Zealand offering Ricochet to their members. Over 80% of Clubs in Queensland offer Ricochet. Queensland Director of Coaching has visited several areas outside Queensland for coaching and rules of the discipline. It is generally felt that Queensland can no longer service all of Australia adequately.
REASON/RATIONALE FOR THE MOTION:	As Queensland State feels it can no longer service the whole of Australia adequately for ricochet, it is felt that that ACA should consider taking over the discipline and offering services in similar ways to what it does the other three Disciplines.
FINANCIAL CONSIDERATIONS/IMPLICATION	S:Financial considerations will be similar to that already in place at ACA for each of the other Codes. At this is stage it is felt that there is not sufficient reason to provide an interstate competition, but it is felt this

could happen within several years
