



New Club Grant Policy

Introduction

1. It is acknowledged that setting up a new croquet club is both a long and expensive process. It is also acknowledged that new clubs should receive some support from Croquet Australia.
2. This policy outlines the process of applying for and the awarding of new club grants.

General.

3. Each year, as part of its budget process, Croquet Australia will include an amount for New Club Grants in its budget, based on information received from State Associations regarding newly established clubs.
4. It is important that the Croquet Australia is assured that any club applying for the grant is viable and it, or its immediate predecessor, has not previously received a New Club Grant.
5. The grant is not available to clubs that are co-located with existing clubs and using that existing club's grounds and equipment.
6. To access a Croquet Australia New Club Grant, a club must meet the following requirements:
 - 6.1. have a minimum of 10 members who are affiliated/registered with their State Association.
 - 6.2. be incorporated either in its own right or part of an incorporated association or legal entity.
 - 6.3. have been affiliated with a State Association for **at least 12 months** prior to making the application.
 - 6.4. make the application within 3 years of first becoming affiliated with a State Association.
7. The application needs to be endorsed by the appropriate State Association and a letter from the State Association supporting the application is also required.
8. Once received the Croquet Australia Secretary and Executive Officer will ensure that the application is placed on the agenda of the next Board meeting for consideration.

Check List for New Club Grant Application

Check List for State Associations and Clubs wishing to apply for a New Club Grant.

The basic requirements are:

1. The Club making the grant application must have a minimum of 10 members who are affiliated/registered with their State Association.
2. The Club is required to have been affiliated with a State Association for **at least 12 months** prior to making the application.
3. The application must be made within 3 years of first becoming affiliated with a State Association.
4. The Club is required to be incorporated either in its own right or part of an incorporated association or legal entity.
5. The application needs to be endorsed by a State Association and a letter from the State Association supporting the application is also required.

It is important that the Australian Croquet Association (ACA) is assured that any Club applying for the grant is viable and it, or its immediate predecessor, has not previously received a new Club grant.
