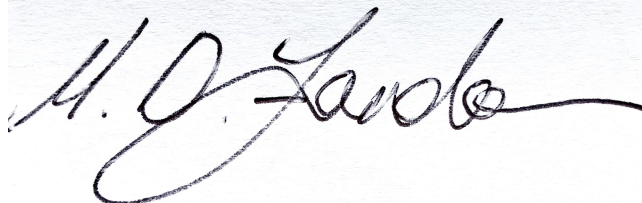

## Secretary's Report

### Insurance 2021

On 22<sup>nd</sup> September 2020 I requested membership, etc. figures from State Secretaries to enable the renewal of the Croquet Australia insurance policies for 2021 (*a copy of the request is included in the Outwards Correspondence for the October meeting*). I received the last states figures on 23<sup>rd</sup> October and forwarded a link to the appropriate Dropbox Folder to our account manager at Regional Insurance Brokers on that date. A phone call to on 27<sup>th</sup> October confirmed that she had accessed the figures but required more data which I have since provided.

### Sale of Surplus Equipment

Pursuant to Board direction, Jim Nicholls and I reviewed all bids and determined recipients of equipment. I have notified all bidders, successful or otherwise, and requested advice as to method of transportation of items. (I also advised that I cannot send anything until Covid-19 restrictions are eased, to allow me to travel to Cairnlea.) I am liaising with Anne Mann to ensure that appropriate invoices are raised.

### AGM 2021

I have commenced negotiations with CNSW on venue, seating requirements and catering for the 2021 AGM, Strategic Forum, Board Meeting and Board facilitated discussions/training, assuming that the Eire Cup will go ahead. If the 2021 Eire Cup does not proceed, then the Board will need to decide whether these meetings are to be physical, and if so, where, or held via technology.

### Lighting Standard

I participated in a Zoom meeting with Kara Chan, Stakeholder Engagement Manager, Standards Australia, yesterday, 10<sup>th</sup> November 2020, who explained that Standards Australia is in the throes of combining AS2560 and all the subsidiary standards into one, as there is much repetition. This is expected to be published by the end of 2021 to early 2022. It is not possible to include croquet in the revision at this time as the committee draft has already been finalised.

However, Standards Australia is intending to seek interest from other sports to have their lighting standards requirements included in the following revision in 2021. It is anticipated that work may commence on this as soon as the revision of AS 2560 is completed. I have expressed Croquet Australia's interest in being included in this revision and being a member of any appropriate sub-committee.

Kara also advised that there is the possibility of an interim Technical Publication which, while it is not an official Standard, offers some guidance to the lighting requirements for croquet. At my request, she undertook to examine our draft document and advise whether or not such an interim Technical Publication is feasible.

### Website:

  - South Australia will also have a team ready for the Eire Cup in March but are also happy to send a team later in the year if the event is postponed.
  - New South Wales will select a team and is happy to go ahead with the event.
  - Victoria and Tasmania hadn't responded at the time of writing.
- **Golf Croquet Under 21 Championships** ○ ACA has been advised by the President of Windsor Croquet Club, Willy Silk that the club will be unable to host the Under 21 Championships in 2022. See attached email. The Under 21 Committee is currently looking at other venue options.
