

WCF Hall of Fame



Executive Officer's Report

Website:

- The new website is now live and can be accessed via the same domain https://croquet-australia.com.au/.
- At the time of writing the handover of the domain from Marketing Sweet to Member Point was taking place. The handover takes two days to complete so the website should be fully operational on Monday the 7th December.
- Some documentation will need to be updated. The new site will need the latest News items and policy documents added to the site. This will be completed by the time of the Board meeting on the 9th of December.
- Currently ACA has not received the final invoice from Member Point. I have been advised that we will receive the invoice once the site is fully operational.

Events

2021 Eire Cup

- As advised at the November Board meeting, all 6 States have been contacted regarding their willingness to attend the 2021 Eire Cup. I have received responses from all States with NSW, Vic, QLD and SA willing to send a team but Tasmania and Western Australia unlikely to attend.
- Western Australia have advised that they won't be sending to a team to the Eire Cup due to the uncertainty around travel and the Covid-19 virus. See email from Croquet West. Following on from the points raised in the email from Croquet West regarding the possible implications of cancelled travel and accommodation. I have contacted our Insurance supplier and requested clarification on cover for cancelling travel. The response from the insurer was "Just on your question regarding cancellations due to COVID, as COVID is now a known event worldwide, any losses associated with (including quarantine costs) COVID would be excluded under Cancellation/Loss of Deposits.

This is not a COVID specific exclusion, but a standard exclusion on the corporate travel wording. Any known event (or not unforeseen) would not be covered under Loss of Deposit/Cancellation, whether it is COVID related or not."

 Tasmania have advised that they will more than likely be unable to meet the female requirements for team entry.

 The cut off for EOI's is the end of December.

NZ CROQUET ENQUIRY FROM PRESIDENT - NCGB has responded

CLARIFICATION BY THE GA REFEREE COMMITTEE IS BEING DEVELOPED RE "POINTING WITH A STICK" AFTER A QLD COMPLAINT RE A REFEREE DECISION AT A QLD COMP. It has long been a practice of referees to stop a captain pointing with a stick to indicate where they wish a player to place a ball. Moreton Bay Club in Qld lodged an official complaint re this. My disappointment with this was that the matter was not referred to the GA referee committee before a complaint was lodged. While WGU rules do not explicitly state that this action is forbidden, there are references in the rules to play interference, definitions of sticks and their use and a prohibition on non-strikers entering a court that provide justification for the long standing practice of referees not allowing sticks to be used as a pointer. The GA Referee Committee will issue clarification as soon as it is able to convene and respond appropriately. The details have been referred to the WGU with a request that "pointing with a stick" is included in the next version of the WGU's Question and Answer Booklet

COMPETITIONS. South Australia were unlucky that their Presidents Cup had to be cancelled at the last minute because of the Covid situation. In Qld 11 teams attended a successful event at Caloundra Croquet Club. No events have taken place in NSW or Victoria

BACKUP DATE FOR THE BIENNIAL AUSTRALIAN GATEBALL CHAMPIONSHIPS 2021 The teams Championships for 2021 and the interstate doubles Championships are to be held on the Gold Coast form the 17th to 19th September 2021. A backup date in April 2022 has been negotiated with the Gold Coast Performance Centre and Peter Freer should it be required in case of a Covid setback
