#### **Action Items from December Meeting**

- The requirements necessary to comply with the Australian National Anti-Doping Policy will be uploaded to the website as soon as possible.
- North Esk CC has been advised of the Board's decision that its application for the New Club Grant was not in accordance with the spirit of the grant (see also New Club Grant Policy below)
- Regional Insurance Brokers (RIB) was advised of the Board's acceptance of the proposed renewal policies, RIB has invoiced the state associations, with Certificates of Currency being emailed to state contacts once premiums have been received.
- · WCF has been advised of the Board's:
  - o acceptance of the 2019 Accounts, the 2020 Treasurer's Report and the 2021 Budget; and
  - o support of Brian Havill's nomination as Independent Examiner
  - o agreement to the WCF proposals regarding Multi Sports Events.
- States have been requested to nominate at least three members to the Croquet Australia Tribunal Panel. To date, the only reply has been from Croquet Victoria. States have also been requested to advertise the Croquet Australia requirement for a Complaints Officer.
- The gathering of further information for an Adverse Playing Conditions Policy is on-going.
- Congratulations have now been extended to all 2020 inductees to the WCF Hall of Fame.

### **New Club Grant Policy**

The policy states only that:

"It is acknowledged that setting up a new croquet club is both a long and expensive process. It is also acknowledged that new clubs should receive some support from Croquet Australia."

#### **Item 9.2.2 Executive Officer Report**

#### Website:

- The website has now been in operation for 3 weeks and is available via the following link: https://croquet-australia.com.au/.
- Board Profiles, Committee Structure and previous year's Tournament Results have been added to the site. There is still a number of Policies that need to be uploaded and this will happen over the two weeks.
- Administrator access has now been given to the ACA Secretary, Jim Clement to enable Board Meeting Minutes to be uploaded.
- Tournament Calendar has been updated to reflect recent changes to Tournament dates but the format needs work. Currently the Tournaments are listed on one page instead of the preferred calendar format. I am working on changing this to a more user free format.
- o The final invoice from Memberpoint has been received and was paid on the 23<sup>rd</sup> of December.

#### **Events**

#### • 2021 Eire Cup

- Croquet Tasmania have advised that they are unable to select a team for the 2021 Eire
  Cup due to the uncertainties with the Covid-19 in Sydney and the related travel
  restrictions. Tasmania are discussing the option of a reduced team on the basis that NSW
  would assist with the player shortfall. See Attachment A for correspondence from
  Croquet Tasmania.
- After consultation with the Events and Tournament Committees some possible options were discussed:
  - Confirm that the Eire Cup go based on travel restrictions be lifted and no further outbreaks.
  - Defer a decision until the end of January. The negative for this would be the teams needing time to organise travel and accommodation. Also, Croquet NSW will need adequate notice to cancel the current arrangements.
  - Defer the Eire Cup until June or August.
  - Postpone for 12 months. Positive for this move would be to restore the 3 year gap between ISS & Eire Cup, and give Tempe 12 months for new lawns to settle.

#### **2021 Golf Croquet Presidents Eights**

- o Expressions of Interests closed on the 3ast December. Events have received 33 entries from all States except Tasmania (NSW 9, QLD 4, VIC 11, SA 6, WA 4, TAS 0).
- Events Chair, Peter Freer is currently in the process of contacting all entries to confirm their Expression of Interest if the event goes ahead.

Audit of the 2020 Financials will be conducted by Heather Stewart from Assurance Matters. A
meeting between Heather, Anne (ACA Finance Officer) and myself is scheduled for the first week
of February.

## The Australian Croquet Academy Report

#### **Game Plan Trial**

Recently a Club Health Check tool was launched by SportAus called Game Plan.

Its purpose is to identify opportunities for improvement in clubs and provide action plans and resources to improve.

Game Plan is currently been trialled by at least one Club in every State to ensure it is croquet friendly.

I would like to send a special thanks to Newtown, Gosnells, Norwood, Bairnsdale, Orange, Bribie Island and Eildon for your participation in this trial.

There are plans to roll out Game Plan to all Clubs soon.

#### **Podcasting**

A proposal was put forward to complete 52 podcasts and have them edited and loaded onto the website.

Several topics are to be covered, including Player Profiles, President Updates and other Guest speakers who are subject matter experts in the field (lawn care).

#### **Coaching Platform**

A proposal was put forward to load all Coaching Materials and property onto a new platform. This is an LMS system that ACA members will be able to sign into and have access to. It would also be dualled onto the Australian Croquet website.

#### **Promotional video**

The first cut of the video has been completed and is currently been reviewed by the Publicity

The plan is to make several social media versions available to clubs.

#### Social Media

A proposal was put forward to engage a professional media company to make several social media clips from the promotional video.

These media clips can then be circulated on social media platforms and specific demographic groups targeted to ensure we get the best results.

#### **Online Magazine**

To date there has been lots of positive responses for the first edition.

Publicity Committee and Australian Board Members to review the next edition.

#### Wikipedia

Putting plans in place to gather information for the website.

#### **Academy Facebook**

To be launched after the new logo is completed.

#### **Academy survey**

A survey has been sent out asking the following questions:

Are you willing to be a guest speaker on a zoom meeting?

Are you willing to be a commentator on Fox, Kayo or other livestream platforms?

Are you available to be interviewed for a croquet specific podcast?

Are you interested in having a Wikipedia page about your croquet achievements?

This information will be used to help plan the above initiatives.

### **National Coordinator of Gateball Report**

Over the past weeks I have dealt with two issues from the World Gateball Union and the Asia Pacific Gateball Union.

I had a request from the WGU to assist them in replying to an email from Geoff Morris. He had asked for the AGU to be registered with the WGU. The draft letter they had prepared rejected that request. I made some corrections in the English in the letter and asked them to include an additional paragraph in which the WGU suggested that Geoff Morris contact the National Coordinator of Gateball in Australia to attempt to resolve his differences with Gateball Australia.

I would like to draw the Board's attention to the fact that this approach was made after the apparently conciliatory gesture that Geoff Morris made after the decision of the 17th June when it was stated that the aims and actions of the AGU were incompatible with membership of the ACA. His actions in the name of the AGU continue to be inappropriate.

Interestingly, the application was accompanied by a number of documents including the minutes of an AGU AGM held in December 2019. This indicated that there appears to be 29 members in Qld. GA believes that about one third of this number are also members of the ACA. Brian Hadley of the Cambridge club is noted to have paid \$70 and an additional payment for 9 members. It is believed that all these people are also members of the ACA. In total, it appears about half the members of the AGU are also members of the ACA.

A similar request was made of the APGU and was rejected.
